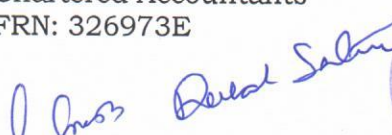
Sub: Limited Review Report on the Unaudited Financial Results for the Quarter and Half year ended September 30, 2025
